6 PRESIDENT'S REPORT

Presidents report 2009/10

After a turbulent year, which was dominated by the financial melt down in some sectors, I want to thank all Society members for their continued support. The Exco worked hard to sort out some of the administrative issues and I must mention Prof Nico Smit (Honorary Treasurer) and Dr Paul Fouche (Honorary Secretary). They went to great lengths to sort out the many mailing lists in existence and the associated problems with membership and payments. I think we now have a more consolidated members list and this reflect in correspondence and reactions to emails and invoices.

To Dr Jan Roos who will take over as President later this year, my gratitude for support and keeping many activities going – I think he regret the brave announcement two years ago to host this conference. Jan, thank you for everything and well done with the conference. 7 TREASURERS REPORT

Honorary Treasurer's report to Annual General meeting

15 June 2010

Dear All

First of all I would just like to apologise for not being able to attend the conference and annual general meeting of the society. I feel specific weird to have been involved in the organizing of the conference and not to see how it turned out in the end. However, just by looking at the program and the names of the delegates I know that I am missing out on a very good conference.

I'll present my reports in 3 parts, first 2009, then the first 6 months of 2010 and will conclude with some suggestions.

2009

My term started in March 2009 and the first priority was to get membership invoices out. Unfortunately at that stage the new committee did not have a proper membership list, so I had to use a list that I received from NISC. This list included everyone that has been a member of SASAQs since 2001. Just to cover my basis I send invoices to all (total of 224 Invoices). As you can imagine I got quite a variety of responses, from members paying fees, to people who resigned back in 2002/2003 being very upset that I bother them again. In the process I also invoiced the editor of AJAS, 2 secretaries working at NISC, both our life members and 2 members who unfortunately have already passed away a few years ago!! Anyway, it was a good learning curve and in the end 102 members paid their annual membership fees, thus an income from membership fees of R30600. Other income for 2009 includes interests from our Current as well as our money market account. Also 2009 conference hosted by University of Johannesburg showed a profit of R18535.50. Our major expenses were payment of subscription to NISC as well as our journals editor's, Mike Coke, honorarium. So to conclude our Moneymarket

account started 2009 with a balance of R152 482.07 and closed in December on R163 262.46. Our current account was R82 710.47 in Jan 2009 and closed on R97 400.60. Thus in total our accounts grew in 2009 with R25 470.52, mainly due to the profit from the 2009 conference.

2010 to date

A total of 179 invoices have been issued to date, this include invoices to the 102 paid up members of 2009, 15 new members and 62 people who were members at different stages from 2003-2008. The latter group was identified by the committee and it was hope that we could entice those previous SASAQs members to rejoin. Of all the invoices to date 94 that have been paid comprising of 68 current members, 2 life members, 8 previous members that rejoined the society and 15 new membership. Our current bank account balances are, R167236.09 for the Money Market and R83722.93 for the Current Account. At the time of writing the report we have already paid almost all the major expenses of the 2010 conference, but still have quite a few conference registration fees outstanding, so ones that have been paid our current account balance will be quite a bit higher.

Conclusion

In all I think our Society is financially healthy and show a steady financial growth. As we don't know what the increase in NISC fees are going to be it is difficult at this stage to propose a membership fee for 2011, but I don't foresee that it will have to increase by more than 5%.

The 2009 financial statements have been submitted for auditing and I will circulate the final audited statements when I receive it back.

8 EDITORS REPORT

The editor of AJAS, Mike Coke submitted the report below and it was presented by Paul Fouche:

Editorial Board: In recent weeks we have decided to abandon the distinction between 'Editorial Board' members and 'Associate Editors'. This is because, as the inflow of manuscripts has increased, several Editorial Board members have agreed to take on subject-editing tasks, which is what the Associate Editors were already doing. Therefore, as from the current issue, all 14 are now listed as 'Editorial Review Board' members. We welcome Ferdy deMoor, Paul Grobler, Frank Kansime, Olaf Weyl and Alan Whitfield to the Editorial Board, and bid farewell to Heimo Mikkola, who has served our journal since its inception in 2000. Thank you, Heimo, for your considerable input over the past ten years !

Manuscripts: The Editorial Office received more manuscripts last year than ever before – 95 in all (Table 1). A major impact was made by the splendid bundle of 16 manuscripts received from the University of Johannesburg research team, which have taken up one-and-a-half issues of the journal, the last ones appearing in 2010. This was the main factor in the significant rise in the proportion of published manuscripts authored by SASAQs members from 31% in 2008 to 83% in 2009. I like to think that the increased inflow of manuscripts is an indication of widespread faith in our journal. Also, if the percentage of manuscripts rejected or withdrawn is anything to go by (52% in 2007, 45% in 2008, and now 35% in 2009), then we're attracting better material each year.

A significant about-face was caused by the arrival of the Johannesburg University manuscripts. For the first time in this journal's history, we suddenly had more 'accepted for publication' manuscripts on hand than was able to be contained in a single issue of the journal! Consequently, not only was I able to hand manuscripts over to the publisher for layout up to a month ahead of deadline, but was also able to start accumulating 'accepted' manuscripts for the next-but-one issue of the journal. If this trend continues (and long may it do so) we might soon be able to publish four issues per year.

However, we could not have achieved the manuscript flow or the publishing turn-around times that have happened without the energetic assistance of our Editorial Board members and Associate Editors, our numerous peer reviewers, and NISC's dedicated publishing team. We owe a debt of thanks to them all.

Journal subscriptions: The numbers of subscribers to the journal in recent years have been as shown in Table 2. There's been an almost steady nose-dive in overall subscriptions, which fell to an alarming 131 in 2008, whilst the number of SASaQs subscribers dropped to a mere 101 last year – which is the absolute borderline for the journal's viability. A membership drive is therefore imperative for our survival. I have advertised the journal to those African Universities from which recent manuscripts have come, so as to encourage submissions from them. A few African authors have recently elected to join the Society because of the very attractive free publishing offer that NISC currently gives to Society members. One hopes that we can interest them sufficiently to keep them on as members.

Journal usage: Full text of our journal, and back numbers, is hosted by Ingenta, EBSCOhost and AJOL, each having different amounts of material available on their site and each serving a slightly different community. Mike Schramm of NISC has kindly provided the following very interesting

information from Ingenta on who uses our journal (Table 3). Note that the downloads were done mainly by subscribers, with some pay-per-view activity by non-subscribers. All in all, the journal is now getting a really high level of international interest, and one hopes that this starts to translate into more article submissions from international researchers as well as more international subscribers.

In comparison, EBSCOhost reported a total of 377 downloads of their top 10 articles from Volumes 33 & 34 (2008 & 2009) alone. However, they don't have as much material available as Ingenta do, and so their downloads are skewed towards the more recent publications.

Impact factor: We have yet to receive our first Impact Factor rating, which is expected to become available during June this year. Having an Impact Factor will definitely improve the status of our journal in the eyes of potential authors, and so should improve both the flow and quality of incoming manuscripts.

Publishing changes: NISC's publishing collaboration with Taylor and Francis has not yet resulted in the setting up of the promised electronic manuscript-handling system. When this happens it is likely to improve both the speed and visibility of the refereeing and publishing process, and thereby should put our journal on a better footing.

Olaf Weyl and Janine Adams were requested to investigate the possibility to host the 2012 conference and it was suggested that the 2013 conference be held in the Okavango.

12 AWARDS

The chairperson reported that no proposals were received.

13 HONORARIA

It was suggested that the honorarium paid to the Editor of AJAS be adapted to include the inflation rate.

14 BY-LAWS

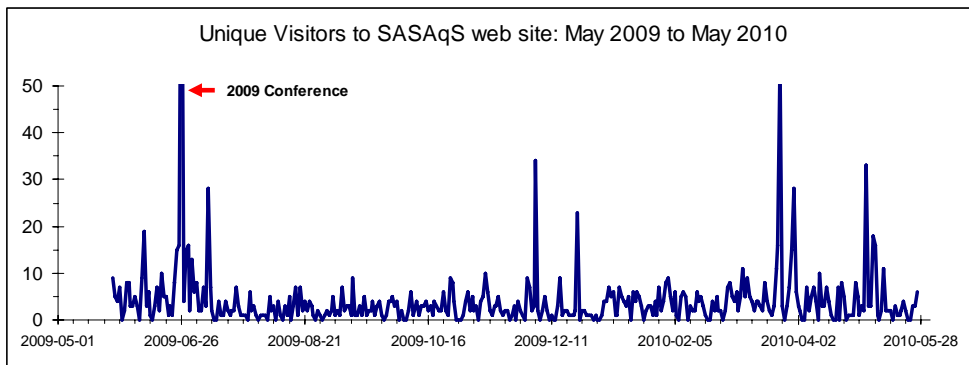
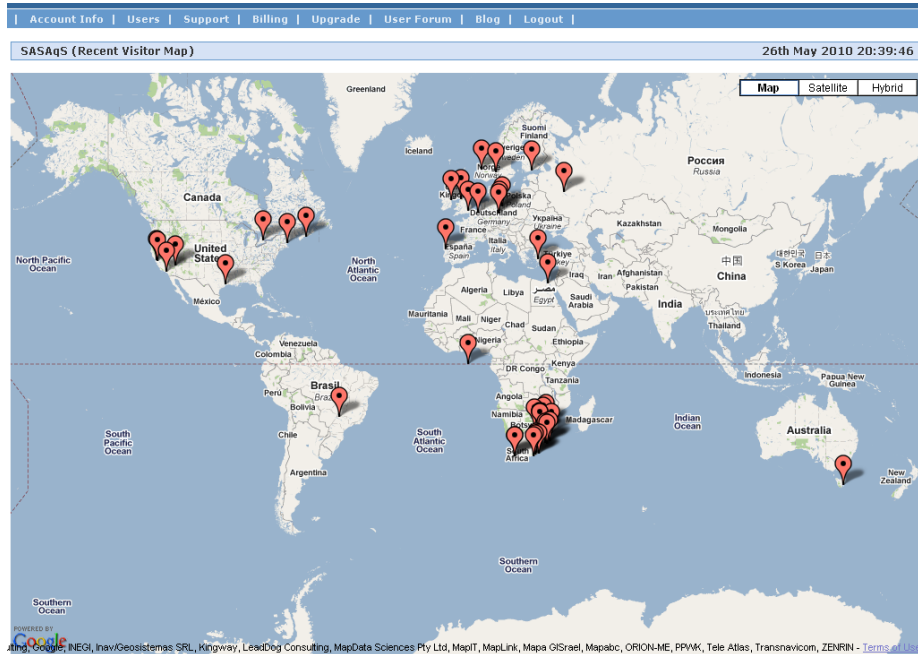
