6. PhD in Zoology with Temporary Lecturer responsibilities. University of Zululand

This position is available in the Department of Zoology at the University of Zululand. The incumbent will be expected to register for a PhD, but will also be expected to present two undergraduate modules (about 8 weeks each) per year for a period of three years.

The Department of Zoology has expertise in the fields of estuarine benthic and fish ecology, marine and estuarine zooplankton, decapod ecology and physiology (including larval development), and marine ecotoxicology.

Preference will be given to candidates with an MSc in Zoology or a related field with a strong background and interest in pursuing a PhD in the fields of estuarine ecology and ecotoxicology. The candidate's research focus will be on factors (including pollutants)

structuring the macrobenthic community within the Port of Richards Bay and the potential use of amphipods in the development of bioassay based sediment toxicity tests for estuaries. The use of amphipods in the development of bioassays to test sediment quality in anthropogenically impacted estuarine environments such as harbours is globally receiving much attention and research interest. It thus provides an extremely interesting and challenging research area, especially for evaluating anthropogenically mediated disturbance in ecologically important estuarine areas. All candidates who meet the requirements will be considered.

Remuneration will be approximately R90 000 per year for three years but does not include extra benefits (e.g. medical aid, pension). Prospective candidates should note that the University is situated about 15 kms from the nearest town Empangeni and a drivers licence and reliable transport is therefore essential.

LECTURER - ONE YEAR CONTRACT

Applicants are invited to fill a Lectureship Leave Replacement position in the Department of Zoology for the period **1st July 2006 to 30th June 2007**. The minimum requirement for the position is an MSc in Zoology, preferably with some teaching experience.

The appointee will be required to undertake a full academic teaching load as well as assist with other departmental matters as and when required. The University operates on a modular system which is effectively a quarter course equivalent of the old year courses. The incumbent will be required to undertake undergraduate teaching in Zoology. Currently teaching allocations have not been completed but modules to be taught will include Introduction to Ecology (1st Year), Introduction to Fisheries & Fisheries Science (2nd Year) and Marine Ecology (3rd Year).

A second staff member in the Department has applied for sabbatical leave from June 2007 to July 2008. The possibility therefore exists that a further one year's teaching contract may become available during the course of the current contract.
